3 **SECTION 1. APPLICATION OF THE FREEDOM OF INFORMA-**
4 **TION ACT TO CERTAIN STATUTES.**

5 (a) AMENDMENTS TO THE SECURITIES AND EX-
6 CHANGE ACT.—Section 24 of the Securities Exchange Act

1 of 1934 (15 U.S.C. 78x), as amended by section 929I(a)
2 of the Dodd-Frank Consumer Financial Protection and
3 Wall Street Reform Act (Public Law 111–203), is amend-
4 ed by striking subsection (e) and inserting the following:

5 “(e) FREEDOM OF INFORMATION ACT.—For pur-
6 poses of section 552(b)(8) of title 5, United States Code,
7 (commonly referred to as the Freedom of Information
8 Act)—

9 “(1) the Commission is an agency responsible
10 for the regulation or supervision of financial institu-
11 tions; and

12 “(2) any entity for which the Commission is re-
13 sponsible for regulating, supervising, or examining
14 under this title is a financial institution.”.

15 (b) AMENDMENTS TO THE INVESTMENT COMPANY
16 ACT.—Section 31 of the Investment Company Act of 1940
17 (15 U.S.C. 80a–30), as amended by section 929I(b) of the
18 Dodd-Frank Consumer Financial Protection and Wall
19 Street Reform Act (Public Law 111–203), is amended—

20 (1) by striking subsection (c); and

21 (2) by redesignating subsections (d) and (e) as
22 subsections (c) and (d), respectively.

23 (c) AMENDMENTS TO THE INVESTMENT ADVISERS
24 ACT.—Section 210 of the Investment Advisers Act of
25 1940 (15 U.S.C. 80b–10), as amended by section 929I(c)

1 of the Dodd-Frank Consumer Financial Protection and
2 Wall Street Reform Act (Public Law 111–203), is amend-
3 ed by striking subsection (d).
